Timber Merchants/Purchasers are advised to check the condition of the Depot Lots and get fully satisfied with quality of the Produce before submitting tender. The tender should be addressed by name of "Divisional Manager, Kolkata Forest Corporation Division, West Bengal Forest Development Corporation Limited, "ARANYA BIKASH" KB- 19, Sec-III, Salt Lake City, Kolkata-700 106" and should be sent in sealed cover super describing the words "Tender for Purchase of Depot lots of Notice No:04/Depot Lots/Kolkata F.C. Division/2021-22.".Tenders will be received up to **24/05/2021 up to 15:00hrs** by post, courier or by hand and will be opened **25/05/2021 at 12:00hrs** in presence of the tenders or their authorized representatives.

The intending purchasers are requested to inspect the depot lots of aforesaid area on any working days before submitting their tenders.

1. The tender forms along with terms and conditions of tender will be available FREE OF COST on any working day from 04/05/2021 between 11:00 am to 4:00pm from the office of the Divisional Manager, Kolkata Forest Corporation Division, W.B. Forest Development Corporation Limited and also it can be downloaded from the website **www.wbfdc.com & www.wbfpms.com**.
2. The officer inviting the tender reserves the right of withdrawal of any Depot Lots mentioned in the schedule annex from tender. He is not bound to assign any reason for acceptance or rejection of any offer of sale for Depot Lots.
3. Any person who is a defaulter in respect of payment of any dues payable to the Divisional Manager, Kolkata Forest Corporation Division, W.B. Forest Development Corporation Limited and subsequently declared defaulters by the respective Divisions are not allowed to participate in tender. Their tender, if dropped by them, will not be considered for the purpose of sale of Depot Lots.
4. The intending purchasers must submit photocopies of valid PAN card issued by the appropriate authorities along with their tender papers. No affidavit in lieu of valid certificate will be accepted.
5. Purchasers are requested to produce photocopies of up to date I.T. Clearance/GST registration certificates, along with their tender papers.
6. No claim for variation of measurement of the individual Lots offered for sale in the sale of Depot Lots will be entertained & Depot Lots will be sold **as is where is basis**.
7. The intending tenders shall be required to deposit **Earnest Money of Rs. 20,000/- (twenty thousand)** by Draft in favour of **Divisional Manager, Kolkata Forest Corporation Division, WBFDC Ltd.**
8. The Earnest Money deposited will be released to the unsuccessful tenderers on receipt of application from them in due course; successful tenderers will be released only after completion of the work.
9. Purchaser should deposit 25% of sale value of lot within 10 (Ten) days of confirmation of sale made to them. Such revenue should preferably be paid by Bank Draft drawn any Nationalized Bank payable at Kolkata in favour of Divisional Manager, Kolkata Forest Corporation Division, WBFDC Ltd. This 25% will be treated as security money till full revenue is deposited by the purchaser. Failure to deposit 25% value of the standing trees within the stipulated period and to sign the agreement in respect of the Depot Lots purchased by him in the prescribed form within 10 (ten) days of confirmation of sale made to him may render the sale liable to be cancelled and the earnest money shall be liable to be forfeited to the W.B Forest Development Corporation Ltd.
10. Balance 75% value of the trees has to be paid within 20 (Twenty) days counted from the day of confirmation of sale made to him. Such revenue should preferably be paid by Bank Draft drawn on any Nationalized Bank payable at Kolkata in favour of Divisional Manager, Kolkata Forest Corporation Division, West Bengal Forest Development Corporation Ltd.
11. **The condition and quality of Depot Lots as annexed in the schedule are not guaranteed. The intending purchasers are requested to inspect the Depot Lots offered for sale to make sure about the quality of timber before submitting tender. No complaints as to quality and condition of said timber will be entertained after tender rates are submitted to the undersigned.**

12. The purchasers shall quote rate for each lot separately. THE RATES SHOULD BE QUOTED TOTAL No. OF DEPOT LOTS BASIS. All rates should be exclusive of GST, Income Tax, Surcharges and other levies etc. which are to be paid in addition to the quoted rate as per the rates in vogue as may be applicable under law. Quoted rates will be finally approved by the General Manager (HQ), WBFDC Ltd.
13. 25% of sale value which is transferable towards the revenue of the same trees shall be treated as security deposit against the said lot till the balance 75% of the revenue is deposited by the purchaser and shall be liable for forfeiture to the Corporation in case of failure to deposit 75% by the purchaser within stipulated time.
14. As a special case & only under exceptional circumstances 75% of the sale value may be accepted beyond 20 (Twenty) days counted from the day of confirmation of sale made to him for 10 more days at the discretion of the officer inviting the tender only on payment of surcharge of 5% on 75% of the sale value. No further extension of time will be allowed under any circumstances beyond this extended time of 10 days and security money shall liable to be forfeited to West Bengal Forest Development Corporation Ltd. In case of any dispute the decision of General Manager (HQ), WBFDC Ltd shall be final.
15. If any last date to deposit the 25% or 75% revenue falls on non-working day, the revenue will be deposited on next working day.
16. The purchaser shall have to be abided by the provisions of the Indian Forest Act, 1927 with all amendments & West Bengal Forest Produce Transit Rules, 1959 while carrying the timber.
17. The purchaser may engage his agent to lift and carry the purchased lots purchased by him. In case the purchaser should issue a formal letter of authority to be approved by the undersigned & such letter of authority must declare that the purchaser shall be held responsible for any irregularities committed by his agent. The undersigned however reserves the right to accept or reject such authorization.
18. All timber extracted from the purchased Depot Lots should have Govt. hammer mark of the sale marking officer.
19. In case any damage is caused to the buildings, roads, telephone line, property, human life or any other installation while lifting or carriage of the purchased lots, the purchaser will be held responsible only. WBFDC Ltd. will not responsible anyway.
20. If the purchaser fails to observe any condition contained in the agreement, it will be lawful for the undersigned to give a notice in writing to the purchaser to terminate the agreement unless the same is terminated due to expiry of time and to forfeit the security deposit of the Depot Lots in whole or in part and to recover from the purchaser such loss as may accrue to the Corporation for such termination of the agreement. In addition to forfeiture of the security money, the purchaser shall be liable to be declared as defaulter and liable to be debarred from participating in future auction/ tender. In case of resale of defaulter lot/lots the original purchaser shall be liable to pay for the loss if any under the public Demand Recovery Act.
21. On special circumstances any condition can be modified changed added with the approval of GM(HQ), WBFDC Ltd and the power of arbitration will vest with the General Manager(HQ), W.B.Forest development Corporation Ltd. whose decision will be final in all respect.
22. All precautionary measures as mentioned in this Tender Notice are to be adopted during lifting operation of the timbers. The process is to be completed within **20 (Twenty) days** from the received of the letter for lifting of trees failing which your deposited bid amount will be forfeited.
23. The lifting of timbers shall not be carried out after the sunset and before the sun rise.

24. This permission is subject to the provision of the West Bengal Forest (Establishment & Regulation of Sawmills and wood based industries) Rules, 1982 & the West Bengal Forest Produce Transit Rules, 1959
25. Transit passes to be taken from the Range Manager, Marketing Range and The Range Manager, Salt Lake Range or his authorized officer for movement of timber.
26. Before taking any extraction works prior intimation to be given to the Range Managers.
27. Any type of police deployment, traffic control will not be done by us.
28. This office will not be liable for any type of damage to any person or any property at the time of lifting operation.
29. Expert/skilled labours or personnel to be deploy for the whole lifting operation.
30. **The terms & conditions of the sale notice mentioned herein above shall be deemed to be a part of the agreement which shall have to be executed by the purchaser after confirmation of the sale of Depot Lots.**
