Tender

1. Background

- 1.1 The West Bengal Forest Development Corporation Limited (WBFDCL) (hereinafter also referred to as the "Corporation") came into existence in 1974 as per Companies Act 1956, on the recommendation of National Commission of Agriculture. The Broad Objectives of setting up WBFDCL was to offer timber, non-timber forest produce and value-added forest products at reasonable prices for the public in general, to develop awareness for conservation of nature and wild life through responsible eco-tourism.
- 1.2 The Corporation has decided to set up 10 Nurseries inside Banabitan Park, Salt Lake, Kolkata (The Project). The details of the Nursery site are provided at Appendix 3.
- 1.3 Accordingly, the Corporation is taking out this Tender to identify suitable Firms who are interested in setting up Nurseries within Banabitan Park.

2. Banabitan Park

2.1 Banabitan/ Central Park situated in Salt Lake, Kolkata is a public urban park. The Park was created by Forest Department in 1991. The Park is spread over 70 acres including a lake in 15 acres, children park of 12 acres and parking area of 4 acres. The Park has several tree species like Mehogani, Sisoo, Shal, Chikrashi, Shegun, several bamboo species, climbers and shrubs. The fauna includes more than 125 species of birds, around 80 species of butterflies, more than 10 species of Mammals along with several reptilian and amphibian species.

Having all these natural attractions, the park is being used by several people with various perspective. During the morning hours, thousands of morning walkers come to the park and thousands of day visitors come to enjoy the serenity of nature as well. Students visit the place for their day excursions and families for relaxation.

For amusement of kids, there is a children's corner with a few rides, 4 pagodas, a few gazebos.

3. Selection of Agency/Firm

- 1.1 WBFDCL proposes to develop nurseries at Banabitan for sale of ornamental, horticulture, floriculture and avenue saplings of seasonal/ perennial types for sales to general public and allocated an area of approx. 2 acres within the Banabitan Park. Altogether, WBFDCL proposes to develop 10 nurseries within the stipulated area. The nurseries will be allocated to suitable agencies appointed through e-tender process.
- 1.2 Interested Firms/ Companies who are able to comply the requirements may submit the Tender duly filled in and supplemented with all relevant documents to WBFDCL for

- further processing as per laid Procedures. Tender not completed in any respect is liable to be rejected summarily.
- 1.3 Interested Agency can submit their Application only through electronic means, as per guidelines provided in Appendix 1.
- 1.4 The selection of the Agency will be finalized on the basis of scoring criteria as laid down in Clause 11.

4. Scope of Work of Selected Agency/Firm

- 2.1 To set up Nursery (for sale only) at the allocated place within Banabitan Park.
- 2.2 To earn revenue from the Project by selling plants to individual/ companies.
- 2.3 To share 25% of the total sale values from the enlisted Nursery.

- 6.3 Any condition or qualification or any other stipulation contained in the Tender shall render the Tender liable to rejection as a non-responsive Tender.

7. Eligibility Criteria

7.1 The Agency may be Proprietorship Firm / Partnership Firm / Private Limited Company / Public Limited Company/ Limited Liability Partnership / Cooperative Society/ Society. No consortium/ joint venture of any sort will be allowed.

7.2 The Agency must have a nursery in West Bengal of minimum area of 2 acres and the same has been operational for the past 2 Financial year preceding the Application Due Date.

7.3 Intending Agency should have prior experience of supplying of Plants and Seedling in Government Departments/ Agencies/ Undertakings in the last 3 years preceding the

Application Due Date.

7.4 Must have a minimum annual turnover of Rs. 50 lacs in any 3 of the last 4 Financial

Years preceding the Application Due Date.

11. Selection Procedure

11.1 In the first stage, the Application submitted by the Agency online will be opened and evaluated to determine whether Agency is meeting the requisite Eligibility Criteria as set out in Clause 7. Agencies meeting the requisite Eligibility Criteria will further be evaluated on the basis of the marking system as given below:

11.2 The Evaluation committee constituted for the purpose, may waive any informality or non- conformity or irregularity in a Tender which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of

- any Agency. Decision of the Evaluation Committee would be final and binding upon the Agencies.
- 11.3 The Applicant will be called to make detailed presentation in from of the evaluation committee on a suitable date as informed by WBFDCL
- 11.4 Decision of WBFDCL in respect of evaluation methodology and short listing of Agencies will be final.

12. Notification of Selection

- 12.1 WBFDCL shall notify the successful Agency/s in the notice board of WBFDCL, in its official website, writing by registered letter or by email, that its Tender has been accepted.
- 12.2 The Agency shall acknowledge in writing, receipt of the notification of selection and shall send his acceptance within seven (7) days of receiving the notification.
- 12.3 Failure to aApplication by this, may lead to termination of the Tender and forfeiture of the Earnest Money Deposit.

13. Earnest Money Deposit/ Application Security

- 13.1 The Agency shall furnish, as part of its Application, a Application Security equivalent to Rs. 10,000/- (Rupees Ten Thousand only).

- 18.2 The undersigned reserves the right to reject the Tender of any Agency who is a defaulter to the WBFDC Ltd. & the Forest Directorate, W B in respect of payment of dues.
- 18.3 The Selection would be for a period of one year which can be extend by another one year subject to satisfactory services and yearly review.
- 18.4 If services provided by the vendor is found to be unsatisfactory or at any time it is found that the information provided for Tender or any tender is false or irregular while applying for the tenders WBFDCL shall reserve the right to remove such vendors from the empaneled list without giving any notice to the vendors in advance.
- 18.5 The Corporation reserves the right to increase/ alter the number of nursery in the Banabitan Park
- 18.6 The evaluation of the Tenders shall be carried out by the committee constituted for the purpose.
- 18.7 Any un-authenticated, alterations, erasures, overwriting, blanking out or discrepancies may render the Tender submission invalid. The evaluation of the response will only be based on the documents submitted and evaluation committee reserved the right to relax the evaluation criteria.
- 18.8 Response submitted by Fax or E-mail or any form other than mentioned above will not be acceptable and liable for rejection by WBFDCL
- 18.9 The Corporation shall enter into an Agreement with the Successful Agency
- 18.10 The successful Applicant will have to submit a Bank Guarantee of an amount of Rs2 lacs by way of Demand Draft/ Bank Guarantee as Security on or before signing of Agreement with the Corporation. The security shall be released within 30 days of the contract period. The Bank Guarantee to be furnished by the Empaneled Vendor in the format as provided in Annexure VI.

- 1.1 Any organization/ agencies willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to https:// wbtenders.gov.in (the web portal of West Bengal Tenders maintained by NIC). The organization / agencies are required to click on the link for e-Tendering site as given on the web portal
- 1.2 Each organization / agency is required to obtain a Class-II /Class III company Digital Signature Certificate (DSC) for submission of Tender from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount.
- 1.3 The organization / agencies can search & download N.I.T. &Technical Application (TENDER) Document(s) electronically from computer once they log on to the website.
- 1.4 Tenders are to be submitted through online before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).
- 1.5 The Agency are advised to submit the Tender well in advance of the deadline as the Kolkata Forest Corporation Division will not be liable or responsible for non-submission of the Applications or submission of incomplete Application on account of any technical glitches or any problems in connectivity services used by the Agency
