3. The rate should be quoted per **cft and rate (%) of GST.**
4. Delivery should be made to Joinery & Carpentry Unit at " EM-5 " Block, Sector -V, Salt Lake City, Kolkata – 700091.
5. Sample of all quoted items, duly marked/ affixed with the name of quotationer should accompany the quotation.
