- Successful bidder shall be that bidder who has submitted the lowest qualified bid.

2. Instruction to Bidders

- Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm and irrevocable.

- b. The Bidder should either be Manufacturer / authorized dealers of the Brand as mentioned under Clause 1.2 above

A. Envelop 1: Technical Bid: The Bidder shall submit the following document as part of its Technical Bid

- iii) EMD/ Security Deposit.
- iv) Trade License (in case of proprietorship firm/ partnership firm)

- vi) In case of Partnership Firm, registered under the Partnership Act., 1932 – Please enclose details of partners, details of their business and partnership deed etc. duly attested by Notary

B. Envelop 2 Financial/Price Bid: The Bidder shall submit all-inclusive financial quotes as its Financial Bid. The price bid quoted by the Bidder shall be inclusive of taxes & duties including GST. The Price Bid shall be exclusive of Freight, which will be paid on actual basis. **The Price Bid quoted by the Bidder shall remain valid for 6 months.**

10. Bid Security

- a. The Bidder shall furnish, as part of its Bid, a Bid Security equivalent to Rs. 6000/- - (Rupees Six thousand only).in the form of Bank DD/Cheque favoring Divisional Manager, Kolkata Forest Corporation Division, payable at Kolkata. The performance deposit will be refunded to the firm within 30 days of acceptance of the delivery.
- g. The supply, installation and commissioning shall take place on staggered basis over a period of 2 months. The price bid quoted by the bidder shall remain valid for 6 months.
