The Broad Objectives of setting up WBFDCCL was to offer timber, non-timber forest produce and value-added forest products at reasonable prices for the public in general, to develop awareness for conservation of nature and wild life through responsible eco-tourism.
- 1.2. West Bengal Forest Development Corporation Limited intends to setup various technological projects to create positive awareness among visitors on animals, wild life, nature, infotainment and to increase foot fall at Alipore Zoo in Kolkata at Alipore Zoo in Kolkata. 9. Empanelment Procedure

9.1 The objective of evaluation methodology is to facilitate the empanelment of technically superior vendors. The applicant's will be evaluated on the basis of Eligibility Criteria as mentioned under Clause 4 and documents as listed under Clause 6 & 7 of this EOI document.

9.2 The vendor will be empaneled as per the following process:

9.2.1 Vendors satisfying the eligibility criteria will be short listed and will be empaneled with Wbfdcl after due scrutiny of documents submitted by the Applicant. Wbfdcl may, at its sole discretion, decide to seek more information from the Applicants. The clarification shall be given in writing immediately.

9.2.2 The Evaluation committee constituted for the purpose, may waive any informality or non-conformity or irregularity in an application which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any applicant. Decision of the Evaluation Committee would be final and binding upon the Applicants.

9.2.3 The Applicant will be called to make detailed presentation in front of the evaluation committee on a suitable date as informed by Wbfdcl. The presentation to include the following

- Brief About the Company
- Similar projects undertaken in different parts of India
- Projects which they want to offer
- Benefits of the Project
- Technology to offer with detailed Technical Specifications

10. Notification of Empanelment

10.1 Wbfdcl shall notify the successful applicant/s in the notice board of Wbfdcl, in its official website, writing by registered letter or by email, that its application has been accepted.

10.2 The applicant shall acknowledge in writing, receipt of the notification of empanelment and shall send his acceptance within seven (7) days of receiving the notification.

10.3 Failure to abide by this, may lead to termination of the empanelment.

11. Terms & Conditions

- 11.1 The undersigned reserves the right to withdraw or include any item without assigning any reason thereof.
- 11.2 The undersigned reserves the right to reject the Application of any Applicant who is a defaulter to the WBFDC Ltd. & the Forest Directorate, W B in respect of payment of dues.
- 11.3 Empanelment would be for a period of six months from the date of issuance of empanelment letter/agreement subject to satisfactory services and yearly review. If services provided by the vendor is found to be unsatisfactory or at any time it is found that the information provided for empanelment or any tender is false or irregular while applying for the tenders WBFDC shall reserve the right to remove such vendors from the empaneled list without giving any notice to the vendors in advance.
- 11.4 The response should be submitted in a structured format as per the checklist appended with number on every page. Each page of the application should be signed by person(s) on behalf of the organization having necessary Authorization / Power of Attorney to do so, duly affixing the company seal. Applications containing false or inadequate information are liable for rejection. (Authorization Letter from the company should be furnished along with the application)
- 11.5 The evaluation of the applications for empanelment shall be carried out by the committee constituted for the purpose.
- 11.6 Any un-authenticated, alterations, erasures, overwriting, blanking out or discrepancies may render the EOI submission invalid. The evaluation of the response will only be based on the documents submitted and evaluation committee reserved the right to relax the evaluation criteria.
- 11.7 Response submitted by Fax or E-mail or any form other than mentioned above will not be acceptable and liable for rejection by WBFDC
- 11.8 During empanelment period, WBFDC reserves the right to de-panel, if the service provided by the vendor is found to be unsatisfactory or if, at any time, it is found that the information provided for empanelment is false, the WBFDC reserves the right to remove such vendors from the empaneled list without giving any notice to the vendor in advance. - 11.9 In order to allow prospective Applicants reasonable time in which to take the amendment into account in preparing their response, WBFDC, at its discretion, may extend the deadline for the submission of response.
- 11.10 WBFDC shall conduct limited tendering process amongst the Empaneled Vendors for selection of successful Applicant/s to undertake different Technological Projects at Alipore Zoo. The scope of the successful Applicant/s will be to Supply, Installation, Commissioning, Training and maintenance of the Project for initial period of 12 months.
- 11.11 During the tendering process, the Applicant/s have to submit an Earnest Money Deposit to be decided at the time of tendering process (normally 1.5% to 2% of the tender value). The EMD of the bidder will be returned after finalization of the bid and selection of successful bidder/s and the EMD of the successful bidder will be returned only after

furnishing of Performance Security (10% of the Project Cost by way of Bank Guarantee/ demand draft) by the successful Bidder.

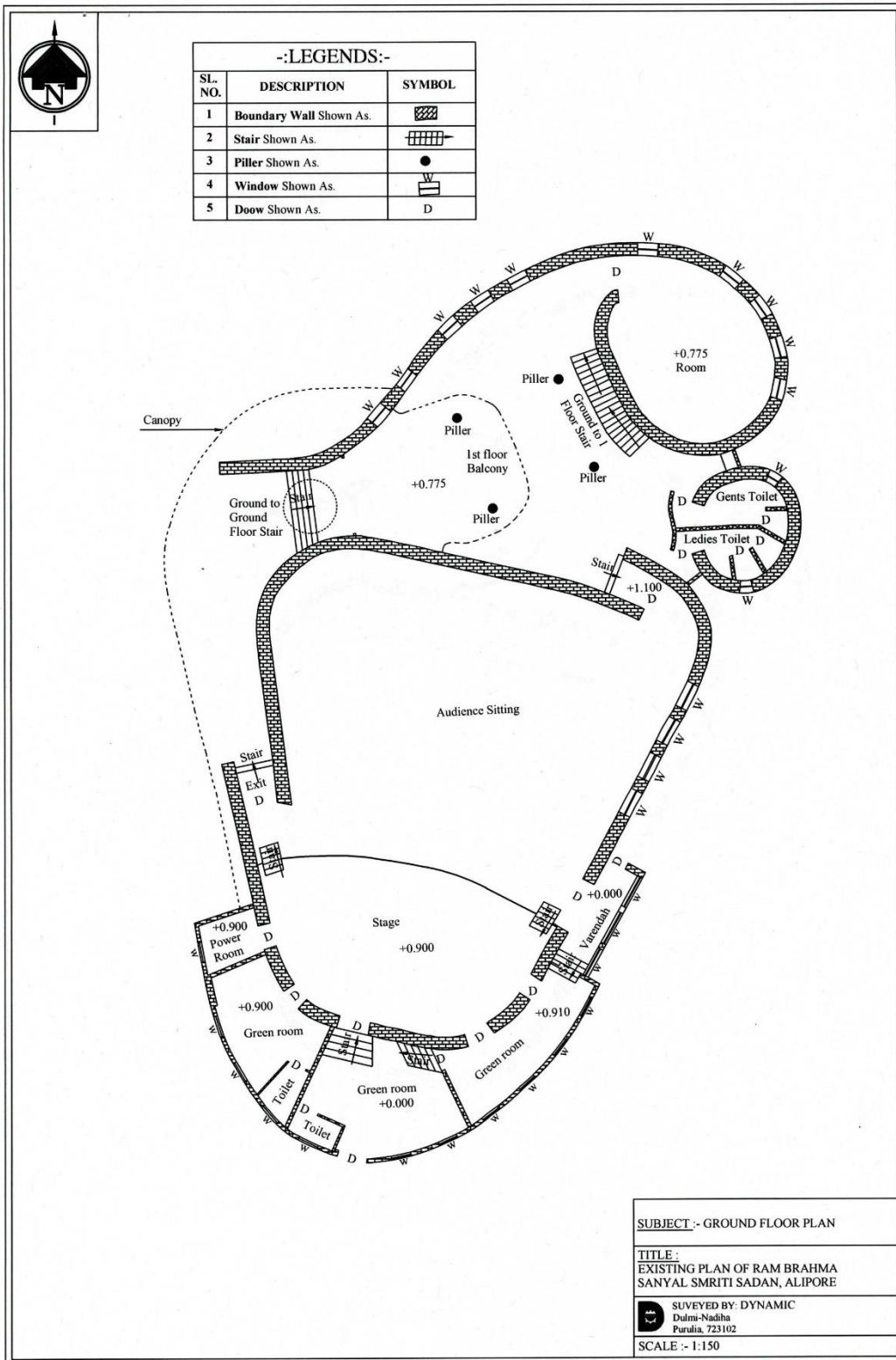

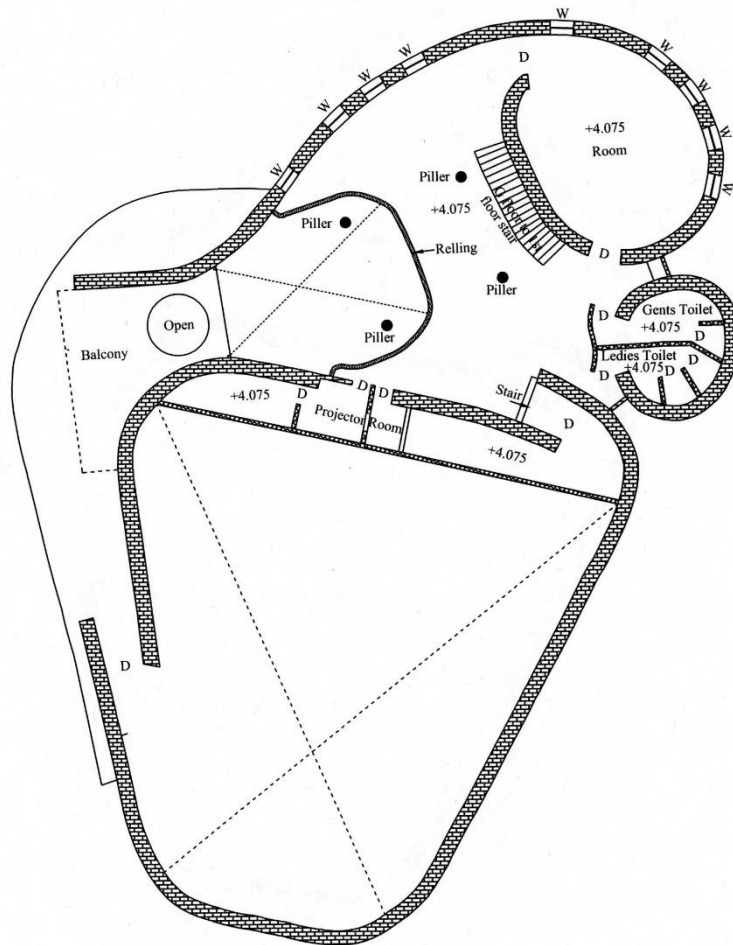
Appendix 2 – Location Map
