1. Background

The West Bengal Forest Development Corporation Limited (WBFDC) (hereinafter also referred to as the "Corporation") came into existence in 1974 as per Companies Act 1956, on the recommendation of National Commission of Agriculture. The Broad Objectives of setting up WBFDC was to offer timber, non-timber forest produces and value-added forest products at reasonable prices for the public in general, to develop awareness for conservation of nature and wild life through responsible eco-tourism.

WBFDC requires 11 numbers of Barbeque-grill machine of the following specifications

Specification	SS 304 Grade Body, Net will be MS, Full body will be Insulated by glass wool 12 nos SS kabab hanging sticks also be fittings with Barbeque.

2. Selection of Agency

- WBFDC invited tenders for supply of 11 No of Barbeque- grill to be supplied to its resorts at Mongpong, Murti (North Bengal) and Banabitan Park, Kolkata (South Bengal)
- The Bid shall be valid for a period of not less than 180 (one hundred and eighty) days from the Bid Due Date ("**Bid Validity Period**").
- Interested Firms/ Companies who are able to comply the requirements may submit the tender duly filled in and supplemented with all relevant documents to WBFDC for further processing as per laid procedures. Tender not completed in any respect are liable to be rejected summarily.
- Successful bidder shall be that bidder who has submitted the lowest qualified bid.

3. Instruction to Bidders

- Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm and irrevocable.

- a. The Bidder may be Proprietorship Firm / Partnership Firm / Private Limited Company / Public Limited Company/ Limited Liability Partnership / Cooperative Society/ Society. No consortium/ joint venture of any sort will be allowed.

- B. **Envelop 2 Financial/Price Bid:** The Bidder shall submit all-inclusive financial quotes as its Financial Bid. The price bid quoted by the Bidder shall be inclusive of taxes & duties including GST. The Price Bid shall be exclusive of Freight, which will be paid on actual basis. **The Price Bid quoted by the Bidder shall remain valid for 6 months.**

11. **Bid Security**

Bid Security is exempted for applicants who are registered with MSME and NSIC for the services for which enlistment is sought on production of documentary evidence

- e. In case the successful bidder resiles from the offer within the validity of tender, the earnest money will be forfeited. - f.
